# Safety recommendations.



In order to ensure correct operation, carefully read the instructions given in this manual before use. Pay special attention to safety recommendations. Retain the instructions, to read it again if necessary. Make this product available to third parties only together with its operating instructions.


- 1. Do not use the fan for other than its intended use.
- 2. Indoor use only. Do not expose the appliance to water, splashes or moisture
- 3. Place the appliance on a flat, firm and heat-resistant surface. Operating the fan in the wrong substrate can cause danger.
- 4. Do not use the fan near objects that may block the air flow such as curtains, loose pieces of paper, foil and the like.
- 5. Disconnect unused device from the power source.
- 6. Connect the power cord to the properly secured power socket.
- 7. Never pull the mains plug from the socket by pulling the cable. Always pull it from the mains socket using the intended grips.
- 8. Damaged mains cable may be replaced by the manufacturer, a workshop commissioned by the manufacturer or a similarly qualified person.
- 9. Refer the repair of the faulty device to the authorized service of the manufacturer, supplier or to qualified service personnel.
- 10. This device is not intended to be used by persons (including children) with reduced physical, sensory or mental abilities or lack of experience and / or lack of knowledge unless they are supervised by a person responsible for their safety or have received instructions how to use the device.




It is forbidden to use device when faulty, with damaged power cable, incomplete as well as with disassembled propeller covers. It is forbidden to insert any objects through the ventilator covers towards the working fan blade.

### Intended use.

The device can be used indoor to circulate air, remove dust, aerate, de-aerate or remove odors. The ventilator has been designed to force the large volume air circulation in the process of ventilation, cooling and drying. It can support other accessories e.g. dehumidifiers or heaters.





# Operation.

1. Place the fan at the workplace. Make sure that air inlet and outlet are not obstructed. The cable must not pose a risk to passing people.

Keep minimum distance to walls or other objects:

- front and rear: 3,0m - sides: 1,0m

Change the inclination angle of the fan if necessary. Fix the position by screwing the clamping knobs.

- 2. Make sure that the fan switch is in the OFF position. Connect the plug of the power cord to earthed power socket.
- 3. Turn the main switch knob to the LOW or HIGH position to obtain the normal or maximum fan speed. Set the switch to the OFF position to turn off the fan.



Do not move ventilator while working! Switch off the fan before moving it. Wait for the fan blade to stop.

#### Maintenance.



Disconnect the device from the power supply before performing maintenance. Wait for the fan components to cool down if necessary.

Keep the ventilator clean and dry. Clean the fan after each opertion. Each time before use, check the state of device condition. Check the condition of the power cord. If found irregularities, contact distributor or an authorized service center of the manufacturer.

Depending on the needs or periodically clean the device using compressed air or if necessary a damp cloth and a mild detergent. Do not use solvents or abrasives.

After having worked for 2000 hours, the fan have to be inspected at the authorized service center of the distributor or manufacturer in order to check the condition and qualify for further work.


Storage: unused device store in its original packaging or in adapted replacement packaging. Store in a dry and safe place. Keep out of reach of children.

### Guarantee.

To obtain guarantee with in the guarantee period, it is an absolute MUST that either a valid receipt or the guarantee card is submitted to the service station together with the appliance.
